Textual Information()	This is to inform you that Honble National Company Law Tribunal (NCLT), Mumbai Bench, vide its order dated 7th November, 2019 approved the Scheme of Amalgamation of AKS Infradevelopers Private Limited and SMG International Private Limited (Public Shareholders of the company) with Raghav Infradevelopers and Builders Private Limited (Promoter Company) becoming effective from 13th December, 2019. The aggregate shareholding of the promoter and promoter group, post amalgamation stands increased at 90.53% as compared to previous promoter and promoter group shareholding of 67.16%. However, transfer of shares are yet to be reflected in the RTA records.
